Section 2: President-Elect---The President-Elect shall; when directed by the President or in the absence of the President, preside at meetings of the Association and the Board of Directors; and when requested by the President or when the President is unable to perform the duties, perform the duties of the President. The President-Elect will act in concert as coordinator for the Regional Co-chairs **and Student Chapters**, and make regular reports to the President regarding the activities within the Regions **and Student Chapters**.

With the information provided the parent/caregiver, s/he can, in turn, give that information immediately to the police to begin a search for a missing or lost child.

Worker Survival...Amongst all the professions, correctional workers (from line staff to administrators) have one of the most demanding and stressful jobs anywhere. Staying healthy and balanced is a priority often overlooked. Survival in these jobs is critical, hence WCA is offering a course to assist workers in coping with the demands and stresses with which they are faced on a daily basis. Entitled *The Art of Correctional Worker Survival*, this work shop will identify strategies for dealing with the stressors in your lives. It will look at ways to stay healthy and balanced both on and off the job. Participants will work on developing their own “Balance Plan” by reviewing their long and short term goals, their time management techniques, and by identifying what is important in their lives as well as learning techniques for taking time for themselves.

The “Survival” workshop is scheduled to take place on June 5, 2007 (Tuesday) from 10 a.m. to 12 p.m. and from 1:30 p.m. to 3:30 p.m. at the DOC Southwest Regional Headquarters Training Room, 637 Woodland Square Loop, in Olympia. Presenter will be Joop DeJong. Audience is expected to include community corrections officers, correctional officers, support staff, supervisors and administrators. There is no cost.

Presented at the 2006 Criminal Justice Conference in Spokane, this workshop received excellent reviews so do plan to attend.

Of the many bills that were introduced and that were designed to impact the criminal justice system, relatively few passed. Of those which did, the following have already been signed by the Governor and will go into effect on the July 22nd date unless noted otherwise. The following bill descriptions are not all inclusive. To find out more about any specific bill go to <http://www.leg.wa.gov/legislature>.

- ✦ **Substitute House Bill 1319** – This bill will expand protection to correctional agency employees, contract staff persons, and volunteers from stalking (a class C felony). The existing statute applies only to community corrections officers. The definition of correctional agency includes the Department of Natural Resources in a correctional setting or any state, county, or municipally operated agency with the authority to direct the release of a person serving a sentence or term of confinement and includes, but is not limited to, the Department of Social and Health Services (DSHS).
- ✦ **House Bill 1431** – A bill which pertains to certificates of discharge will eliminate the requirement that the state Department of Corrections (DOC) maintain a database of all felons for the voter registration listing.

Plans are in the works for a memorial to slain correctional personnel

Individuals attending last years Joint Fall Conference had an opportunity to purchase a small book entitled *Quiet Service II*, a book containing numerous vignettes culled from the experiences of two retired correctional professionals, Bob Kastama and John Prideaux and for which they received the WCA 2006 Citizen's Award. Preceded by *Quiet Service I* (See "Everyone Has a Story below), *Quiet Service II* was published by Bob and John with a goal of using all profits from its sales to establish a Michael Erdahl Memorial Fund in memory of a slain Parole and Probation Officer. The end goal was that of development of a Correctional Personnel Memorial.

So far, \$2,000 has been collected toward this end goal and the two co-authors have now teamed with the Washington State Criminal Justice Training Commission (WSCJTC) to plan the construction of the memorial. They are looking for a few additional people to help in this effort. Everyone has a story

(Editor's Note: The following is "the story behind and the purpose of the books *The Quiet Service I* and *The Quiet Service II*.)

Five years ago my close friend and co-author of *The Quiet Service* books, former WCA President John Prideaux, and I decided that the current generation of correctional personnel might profit from knowing some of the culture of corrections during what we believed were the "Golden Years" of corrections in the state of Washington.

An equally important motivation for doing so was to bring about the promotion and establishment of a Michael Steven Erdahl Memorial honoring those in corrections who have lost their lives in the line of duty (I will address this later in this article).

We decided the one thing we could do was write about our personal experiences in corrections prior to the implementation of the retributive justice law (Sentencing Reform Act) in 1984.

The idea for writing this book has its roots in my early childhood referring to the many stories my friends and I used to hear when company would gather at my parent's home. My mother would almost always say "Somebody needs to write this down. It would make a good story."

It always stuck in my mind that no one ever did and as a result, these stories were lost, sadly, forever.

Subsequently, I was introduced to a newspaper reporter who weekly writes a column entitled "Everyone has a Story". The stories were short, straight forward, about ordinary people. Readers loved it. It later became a nationally published book.

After reading some of these stories we felt cautiously qualified to write our own stories and therefore not repeat the error of my mother and her friends.

Consequently, John and I started out by soliciting stories from our retired colleagues in corrections. All told, 18 submitted some of their experiences which resulted in our first book of 50 stories entitled *The Quiet Service*. It was an "in-house" success. However, we felt we had only uncovered the "tip of the iceberg" and decided that between the two of us we had at least 100 more stories. We whittled *The Quiet Service II* down to 83.

What about the stories? We sincerely doubt that there is another book like it. The stories are stories lived by the authors, with names, places and identifying data camouflaged. Some are deadly serious while others would make you laugh out loud.

You would find admitted mistakes in judgment, often made on the spur of the moment, often made through inexperience, almost always without benefit of counsel, decisions made because situations arising demanded quick and decisive action, be it right or wrong, good or bad. These are gut level stories. Honest and truthful. Nothing is held back.

But most of all, hopefully, these stories reveal the human-ness of most offenders and that of two men, unarmed, without benefit of today's technology and training, and how they went about the dual responsibility of protecting the public and rehabilitating the offender.

That said, now to the most important aspect of this article, the establishment of the Michael Steven Erdahl Memorial.

As many may recall, on May 29, 1985, the correctional community was shocked to learn Michael Steven Erdahl (Mike to all of his colleagues), Probation and Parole Officer II, had been tortured and murdered. The case has never been solved and neither has there been a special memorial set aside for Mike, nor specifically for any fallen correctional personnel in the State of Washington. It is time something be done.

Representatives from Department of Corrections (DOC), WCA, WSCJTC, and John and I, plus others have expressed a deep interest that such a memorial be established. To that end a planning meeting is being developed by WSCJTC during the month of May 2007 to get the ball rolling.

The authors of *The Quiet Service* and the *Quiet Service II* have dedicated all profits from the sale of the above mentioned books to the establishment of this memorial in the name of Mike Erdahl and for all correctional personnel in the state who have been killed in the line of duty at the hands of others. We currently have \$2000 ready to be appropriately dispersed for this purpose. We thank those who have already purchased books and invite other to do so.

Memorials recognize fallen heroes

Turn to the Washington State Criminal Justice Training Commission's (WSCJTC) Memorial Page on their web and you will find information about their Memorial Garden. The Garden includes the Fallen Officer's Memorial, the K-9 Memorial Listing, and the Corrections Memorial Gate. The latter is a gate which was created for the McNeil Island Penitentiary when it was a U. S. Federal Prison during the early 1900s. It was donated to WSCJTC by the State of Washington Department of Corrections, after they took over the administration of that prison Complex. Graduates of the Commission's Corrections Officer Academy pass

through this gate as part of their graduation ceremony. As noted by WSCJTC, "They symbolically emerge as Corrections Officers charged to carry out their duties in Service to their communities, with Integrity of character and Pride in their profession." An additional memorial to fallen corrections personnel will make an important addition to this Garden.

Another memorial established to honor slain law enforcement and corrections personnel now exists on the state capitol's grounds. Overlooking Capitol Lake, Budd Bay and downtown Olympia, it provides a breathtaking view of the Olympics and offers an ideal place for citizens to stop and contemplate not only the lovely scenery, but the lives that have been given so that we all might be safe. It is a fitting location for such a shrine.

Be on the lookout...

If it's not one thing it's another when it comes to identity theft. Now it's new 'Phishing' scams. What is 'Phishing'? The Washington State Employees Credit Union (WSECU) describes it as attacks which are "...usually fraudulent e-mails aimed at stealing consumers' personal identity data and financial account credentials. 'Spoofed' e-mails often lead consumers to counterfeit websites designed to trick recipients into giving away their important financial data such as credit card numbers, account usernames, passwords, and Social Security numbers. Hijacking brand names of banks, retailers, and credit card companies, phishers can trick consumers to respond to email." WSECU reports there is now a new twist in the phishing line. Specifically, scammers are using deceitful emails to direct victims to call a customer support number where a voice response unit or individual awaits to gather your personal information. Once they have it they are able to take over accounts or, even worse, assume their victim's identity.

Some telltale phishing signs include phrases such as "Please contact us immediately" or "Immediate Attention Required." Other phrasing will threaten account closure or suspension if you do not respond. Victims are often encouraged to click a link to a Web site or to contact a customer support number. These are usually phony Web sites that may look like the real thing but aren't. Some times, victims are directed to the company's actual Web site – but watch out! Those are the cases in which a pop-up window quickly appears, enticing victims to enter their personal information.

What do you do if you suspect you're the subject of a 'Phishing' expedition? Here are some suggestions provided by the Credit Union:

- **Never provide your personal information** in response to unsolicited requests.
- **Never provide your password** over the phone or to unsolicited Internet request. A financial institution would **Never** ask you to verify account information on line.
- **Never click on the link** suggested in an email you didn't initiate.
- **Do not be intimidated** by email or a caller who suggests dire consequences if you don't provide or verify financial information.
- **Go to the company's Web site** by typing in the site address directly.
- **Before you return a call you suspect, research unfamiliar area codes** first using legitimate local phone companies.
- **Scrutinize your email** for telltale signs of a phishing attempt such as poor grammar, typos, strange Web site addresses, etc.

If you are the victim of a Phishing attack, act immediately to protect your accounts and your identity. Alert your financial institution as soon as possible, place fraud alerts with all credit card companies with whom you have an account, and monitor your credit card and bank account statements closely.

What's Happening?

The Local Scene

New jail chief named to head Thurston County Corrections Department...After 16 years as Thurston County's chief jailer, Chief Corrections Deputy Karen Daniels has resigned her position following the election of a new Thurston County Sheriff, Dan Kimball. *The Olympian* reports Daniels was seen as doing a great job but, as appears to be the case with new administrations, the new Sheriff wishes to appoint his own leadership team. Named to replace Daniels, Captain Todd Thoma will take over the position on July 1, 2007. This will allow for a smooth transition. Thoma, himself, has been employed in the sheriff's office for a number of years, working his way up to his current rank as captain at the jail.

Mental health a serious issue amongst juvenile offenders...

The Juvenile Rehabilitation Administration (JRA), Department of Social and Health Services (DSHS) reports that more than 60% of the youth in JRA residential care are in their Mental Health Target Population (MHTP).

To combat these serious problem, JRA staff work with consulting psychiatrists and staff psychologists to assist with MHTP assessment, treatment planning, and medication management. Additionally, rehabilitation counselors received training, including suicide prevention and intervention, to work with these youths. MHTP treatment and intervention is cognitive-behavioral drawing, in large part, from **Dialectical Behavioral Therapy**, a course of treatment developed by Marshal Linehan, Ph.D. The goal of this therapy is to teach youth coping skills that will enable them to deal with and manage their disorders, with frustration, recover from past trauma and abuse, and make and keep positive friends.

Two JRA institutions – Echo Glen Children's Center and Maple Lane School – have specialized MHTP treatment units with enhanced staffing for youth with acute and serious mental health needs. The other four institutions have Mental Health Treatment Coordinators who assist transitioning youths with Medicaid applications and referrals for continuing psychiatric services through community mental health Regional Support Networks.

DOC Work Release programs receive ACA accreditation...

Stafford Creek Corrections Center Press Release of April 16, 2007 (see ACA WEB SITE) has announced that so far this year five of the Department of Corrections' prisons have been accredited by the American Correctional Association. The facilities passing the stringent accreditation requirements include Coyote Ridge Corrections Center, Airway Heights Corrections Center, Stafford Creek Corrections Center, Clallam Bay Corrections Center and Cedar Creek Corrections Center. It is anticipated eventually all 15 of DOC prisons will be audited and accredited as well. To date not only the five prisons but all of the Work Release facilities have been so audited and certified.

The accreditation process is an exhausting one. It requires written policy and procedures to establish a training and staff development program for all categories of personnel. The requirements must address all pre-service and specialized training curricula with clear timelines, and consideration given to the institution's mission, physical characteristics and inmate populations. It requires that the professional growth of employees is systematically developed through training plans that annually identify current job-related training needs in relation to position requirements, current correctional issues, new theories, techniques and technologies.

An ACA audit involves assessments that cover administration and management, the physical plant, institutional operations and services, and inmate programs. It also assesses issues and concerns that may affect the quality of life at a facility i.e. staff training, adequacy of medical services. Sanitation, use of segregation and detention, incidents of violence, crowding, offender activity levels, programs, and provisions of basic services that may impact the life, safety and health of inmates as well as staff.

While a rigorous process, DOC Secretary Harold Clarke notes: "Successful accreditation demonstrates our staff's commitment to operating safe, secure and orderly facilities. Achieving accreditation is a difficult goal. It takes months to prepare for the accreditation and audit, but is well worth the time and effort. Accreditation results in overall improvements in the facility as well as improved safety for the staff and offenders."

Teenage drinking and smoking in Washington state may be leveling off...

After significant declines in teenage drinking and pot smoking since 2000, these rates appear to be leveling off. Responding to a Healthy Youth Survey, a quarter of the seniors said they had engaged in binge drinking in the past two weeks – among 10th and 12th graders, 20 percent said they had been drunk at school in the past year. Smoking (cigarette) decline has reach 40 to 60 percent decline since 2000 leaving about 20 percent of the seniors, 15 percent of the tenth graders and 6 percent of eighth graders as cigarette smokers. Pot smoking by eighth graders also seems to have declined somewhat but remains much the same for sophomores and seniors.

Schools cracking down on online

harassment...As might have been expected, harassment is no longer confined to local school grounds – it is now carried on through posted online threats, harassing e-mails and other electronic means. Known as cyberbullying, it is a phenomenon that educators say is growing as more students text message with cell phones and post messages, photographs, and videos at sites such as www.myspace.com and www.youtube.com. As one student pointed out, "It's a lot easier to say something over a text than it is to their face." Schools move to bar cyberbullying is likely to come now that the Legislature has passed Senate Bill 5288. This act would require districts to expand their bullying policies to include electronic acts. The Office of the Superintendent of Public Instruction and the Washington State School Directors' Association are to provide guidelines for this process.

The National Scene

To drink or not to drink...Studies have appeared to show that a glass of red wine a day will provide you with all types of benefits health wise. And, who can resist a cold glass of beer after a hot day? Unfortunately, if one is to believe a news release from the *Milwaukee Journal Sentinel*, either can be dangerous for your health. According to their report, a new study has found that drinking, over time and whether moderately or heavily, was associated with decreased brain volume. While the degree of decrease was less for light or moderate drinkers, only abstainers were found to have no alcohol-related atrophy. And for women, the effect was even greater than for men. Whether this decrease was actually caused by alcohol and whether it actually contributed to any decreased cognitive function, remains to be seen.

The research, which included MRI brain scans of 1,839 people who are a part of a Framingham study, was presented to the American Academy of Neurology at their annual meeting on May 2nd. The study included people who ranged in age from 34 to 88 and was divided into five groups: nondrinkers; former drinkers; low drinkers (one to seven drinks a week); moderate drinkers (eight to 14 drinks a week); and heavy drinkers (more than 14 drinks a week). According to the report, nondrinkers were the only group who had not seen progressively greater amounts of decreased brain volume. Heavy drinkers had the biggest decrease.

- ✦ **Senate Joint Resolution 8212** – Because this bill proposes an amendment to the Washington State Constitution, it will have to be placed on the state’s next general election ballot. Under this bill, the Correctional Industries Class I program, will be reinstated to the DOC. If the vote passes, private businesses will once again be permitted to operate within prisons and employ offenders. This bill has been filed with the Secretary of State’s Office
- ✦ **Engrossed Second Substitute Senate Bill 6157** – An extensive bill, a number of the provisions were the result of recommendations by the Joint Task Force on Offenders Programs, Sentencing and Supervision, a Task Force created in 2006. Among other things, this bill will include: establishment of a minimum of six Community Justice Centers (CJC) by December 1, 2009 and , by December 1, 2011, an additional three CJCs (at least two to be in Eastern Washington); development of individual reentry plans using standardized and comprehensive assessment tools - the initial assessment to be conducted no later than 45 days after sentencing to DOC. Individual reentry plans are to be developed no later than 60 days after completion of assessment with periodic reviews/updates. Offenders on community custody/placement are to be released to county of origin i.e. county of the individual’s first felony conviction; requires an offender arrested for a new felony while under DOC’s community supervision to be held in confinement until a hearing or formal charge is filed – whichever is earlier; requires a Legislative Task Force to be convened by August 1, 2007 to study laws related to community custody and community supervision, said Task Force to include a Community Corrections Officer and the DOC Secretary or designee. This bill has been delivered to the Governor.
- ✦ **House Bill 1220** – This bill will change the number of full-time Indeterminate Sentence Review Board (ISRB) members from two to four with the Chair serving as a fully participating member of the Board and Director of the Agency.
- ✦ **House Bill 1592** – Revises provisions relating to ISRB’s setting of minimum terms and provides for some offenders to petition for earlier review in some circumstances. Also, a determinate plus offender who has been released but violates the terms of supervision may be sanctioned to confinement in a local correctional facility for each violation. In setting a new minimum term, the IRSB may consider the time necessary to complete treatment or other relevant factors relating to release.
- ✦ **Substitute Senate Bill 5118** – this deals with Sexual Harassment within state agencies. It requires the Director of the Department of Personnel to establish guidelines for policies, procedures, and mandatory training programs on sexual harassment to be adopted by state agencies for state employees.
- ✦ **Substitute Senate Bill 5190** – This modifies provision relating to the collection of legal financial obligations requiring that inmates sentenced to life imprisonment without possibility of release or parole, or to death, be subject to the same deductions as other inmates with an exception of mandatory deductions for an inmate savings account. The Secretary of DOC may exempt an inmate from the requirement if the earliest release date exceeds the inmate’s life expectancy.
- ✦ **Senate Bill 5332** - This bill requires the Washington Association of Sheriffs and Police Chiefs (WASPC) to integrate a statewide automated victim information and notification system into its electronic central booking and reporting system, thus providing victims the ability to subscribe to the system and to indicate their notification choice i.e. email, telephone, or post. Information to be provided the victim includes notification of release, transfer, discharge, or escape of the relevant offender. DOC will not be required to provide information to WASPC until January 1, 2010 in order to facilitate technology improvements.
- ✦ **Substitute Senate Bill 5634** – This revises corrections personnel training provisions. Specifically, it requires that within a year of completing core training requirements, corrections personnel are to successfully complete all remaining requirements for career level certification as prescribed by the Criminal Justice Training Commission. The bill has been delivered to the Governor.

The following excerpt from the Washington Correctional Association bylaws explains the nomination and election process:

ARTICLE X (Nomination and Election Procedure)

Section 1: Any current member of the Association may be nominated for any elected office of President, President-Elect, Vice President, Treasurer, Secretary and Regional Co-Chairs.

Section 2: The *Nominations and Elections* Committee shall contact the membership in writing at least 120 days prior to the first day of the Annual Conference in odd years and ask for suggestions for nominations for the offices of the Association. The responses must be in the hands of the *Nominations* Committee within 50 days of the request. Any person whose name appears on more than 20% of the responses shall be nominated. The nominations Committee shall submit a list of two or more nominees for each office, selected by member response or by the Committee, and a brief resume of professional association activities of each nominee, to the Secretary at least 45 days prior to the first day of the Annual Conference.

Section 3: The Secretary of the Association shall mail, thirty (30) days prior to the first day of the Annual Conference, one ballot, which will have space provided for write-in nominees, to each member of the Association whose name and address

appears in the record of the Association as a member whose dues are paid as of the current calendar year. Ballots shall be accompanied by voting instructions, a stamped return addressed envelope bearing the printed notation "BALLOT," and the resume of each nominee. Members of the Association shall mark their ballots and return them to the Secretary by U.S. Mail. Ballots shall not be counted unless they are in the hands of the Secretary by the morning of the second day of the conference. The Secretary shall deliver all ballots in unopened envelopes as received from members to the *Nominations and Elections* Committee for tabulation.

Section 4: The *Nominations and Elections* Committee shall tabulate the ballots with at least four members of the Committee present and participating at all times. They shall report the results of the ballot tabulation to the Secretary and to the President of the Association prior to the announcement to the general membership.

Such report shall be in writing and recorded in the Secretary's file. The person receiving the highest number of votes for each office shall be elected to said office. In the event of a tie the winner will be decided by lot to be cast by the Chair of the *Nominations and Elections* Committee no later than the next scheduled Board Meeting.

Section 5: The Secretary shall notify all persons who are elected to office, but not attending the Conference, of their election by U.S. Mail.

Section 6: By the last day of the Annual Conference there shall be provision made for official installation of the newly elected officers.

Old Business

Minutes: Minutes from the January 12, 2007 meeting were reviewed. Rich LaRosa noted that the meeting was held at Pierce College rather than CJTC as noted. No other changes were made. Pamela moved to amend meeting minutes and accept with changes; Dick Sande seconded the motion. Motion passed.

Old Business
